Employee Verification GDPR menu

On the **Employee** menu, between **Statutory Payments** and **Override Figures**, we have added a new **Employee Verification GDPR** menu with the following options:

- **Stop Sending Employee Data** - stops the employee's payroll data from sending to the EVC platform.

- **Delete Employee Data** - removes the employee's data from the EVC data hub.
- **Request Employee Data** – sends a request for a report of the data held.

Veteran Date

In **Employee Details – Tax/NI** tab, the **Veteran Date** field has been updated, allowing you to enter a date later than the employee's start date.
